- Please note that registration to the annual general meeting must be made no later than June 16, 2020, even if the shareholder chooses to vote in advance. Instructions for this can be found in the notice to the annual general meeting
- Please note that a shareholder whose shares are nominee-registered must register the shares in his/her own name in order to vote. Instructions for this can be found in the notice to the annual general meeting
- If the shareholder does not wish to exercise his/her right to vote through advance voting, the postal voting form shall not be submitted

The shareholder cannot give other instructions than to choose one of the specified response options below at the respective agenda item in the form. If the shareholder wishes to abstain from voting on any agenda item, please do so by not selecting any alternative. If the shareholder has provided the form with special instructions or conditions, or changed or supplemented in the pre-printed text, the vote (ie the advance vote in its entirety) is invalid. Only one form per shareholder will be considered. If more than one form is submitted, only the most recently dated form will be considered. If two forms have the same date, only the form that was most recently submitted to the company will be considered. Incomplete or incorrectly completed forms may be left unanswered.

The advance voting form, with any attached authorization documents, must be received by AB Fagerhult (publ) no later than 16 June 2020, 5 pm CEST. After the aforementioned point in time, an advance vote can only be revoked by the shareholder attending the meeting, himself/herself or by proxy.
